#### Lawther—Deer Park Prairie Preserve

This is an opportunity that doesn't come along very often. Access to Deer Park Prairie Preserve is by appointment only and requires a guide. You are going to see one of the few sections of gulf coast prairie remaining. Expect to find wildflowers, insects and butterflies, and a variety of animals. Check it out on the internet.

We will meet at 8:30 at 1222 E. Purdue Lane, Deer Park, 77536. This is a residential area. Because there is limited parking, please consider carpooling. And do not park along the curb directly in front of the neighboring houses.

Be prepared for uneven terrain, biting insects, plants with thorns. Wear closed-toe shoes, long pants, a longsleeved shirt and a hat. Bring water and insect repellant. Bring both a regular lens and a macro lens, if you have one. You also need a signed release waiver, found on the last page of this Rangefinder.



#### **RELEASE AND INDEMNITY**

In consideration of the right to enter the Lawther - Deer Park Prairie Preserve (L-DPPP) owned by the Native Prairies Association of Texas (NPAT), I release, acquit and forever discharge NPAT, its chapter(s), its officers, servants, assigns, agents, or employees (hereinafter referred to as RELEASEES) from any and all claims or causes of action of any kind whatsoever, at common law, statutory or otherwise, that may arise from my use and entry upon such lands. This Release shall include any accident, incident or occurrence proximately caused by the negligence of the RE-LEASEES.

Further, I understand that in any event involving activities in nature there is a certain risk of injury. I hereby acknowledge that the organizers have given me warning that the events they are sponsoring may involve pot holes, rough footing, wildlife such as ticks, wasps, other biting or stinging insects and snakes, plants that may have thorns or cause contact dermatitis or other allergies, tripping hazards from vines, and other unforeseen hazards. I have taken into account my own physical condition prior to my participation in these activities.

I further agree that I, my heirs, successors and assigns, will not make any claim or institute any suit or action at law or equity against the RELEASEES arising from any such accident, incident or occurrence.

I further agree to protect, indemnify and hold harmless the RELEASEES for any loss by them arising from any acts by me, whether negligent or not, while I am upon or are using the L-DPPP.

I UNDERSTAND THAT BY SIGNING THIS RELEASE AND INDEMNITY, THAT I HAVE AGREED NOT TO BRING SUIT OR ASSERT ANY CLAIM AGAINST THE RELEASEES EVEN THOUGH I OR OUR PROPERTY ARE INJURED OR DAMAGED AS A RESULT OF THE NEGLIGENCE OF THE RELEASEES, THEIR RESPECTIVE GUESTS OR ANY OF THE ABOVE DESCRIBED PARTIES WHILE I AM UPON OR USING L - DPPP. I ALSO UNDERSTAND THAT I HAVE AGREED TO INDEMNIFY, PROTECT AND HOLD HARMLESS THE RELEASEES FOR ANY ACTS BY ME WHICH CAUSE DAMAGE OR INJURY WHILE I AM ON L - DPPP.
